Recruitment to the posts of SCT Sub Inspectors of Police (Civil) (Men & Women), SCT Reserve Sub Inspectors of Police (AR) (Men & Women), SCT Reserve Sub Inspectors of Police (APSP) (Men) in Police Department, Deputy Jailors (Men) & Deputy Jailors (Women) in Prisons & Correctional Services Department and Station Fire Officers (Men) in A.P. Fire & Emergency Services Department was notified vide Notification Rc.No.216/R&T/Rect.1/2018, dt: 01-11-2018.

2) The candidates were advised to download their data and marks obtained by them in the Final Written Examination from the website www.slprb.ap.gov.in on 20-06-2019. Further, an opportunity also given to the candidates to send a mail for data correction if any, from 20-06-2019 to 25-06-2019. After data correction, the number of candidates Qualified for various posts is as under:-

3) The Merit List is divided into three parts:-

- (i) The Merit List for the posts of SCT SI (Civil) (Men & Women) & Dy.Jailor (Men & Women) consists of 400 marks in Final Written Examination;
- (ii) The Merit List for the posts of SCT RSI (AR) (Men & Women) & RSI (APSP) (Men) consists of 300 marks i.e., 200 marks (50% of 400) +100 marks for Physical Efficiency Examination (PET), totalling 300 marks;
- (iii) The Merit List for the post of Station Fire Officer (Men) consists of 400 marks in Final Written Examination.

4) Selection Lists for all the 6 categories has been prepared as per Rules of Reservation / Vacancies notified / Academic Qualifications / Age-Relaxation / Horizontal Reservation and any Other Claimed Benefits. The post preference and Unit preference submitted by the candidates were considered while preparing Provisional Selection List.

5) The Provisional Selection List of the selected candidates has been uploaded on the website "slprb.ap.gov.in" and the cut-off marks for the following posts under various categories are also available for the benefit of candidates.
